Documentation showing the inmate was provided the reasons for restrictive housing within 12 hours;</p> <p>C. Hourly physical observations are conducted;</p> <p>D. Daily medical review by a qualified healthcare professional; and</p> <p>E. If the inmate has past her due date, she will be moved to medical housing.</p> <p>II.
