1.03	Annually	if the agency has a strategic plan, it will include provisions for a documented annual review	
1.04	Quarterly	the jail administrator will report facility activities, in writing, to the parent agency	
1.05M	Annually	the facility maintains current FMJS inspection reports and related corrective action documentation	
2.02M	Annually	the agency electronically submits a report documenting compliance efforts with accreditation standards by January 31 of each year	
3.04	Annually	insurance coverage for worker's compensation, civil liability for employees and volunteers, and liability for official vehicles	
6.02	Annually	requirement for performance evaluations to be conducted at least annually	
8.03M	Annually	a written directive requires all employees receive annual training on exposure control	
9.01M(A)	Annually	authorized personnel receive appropriate firearms training

10.05M	Hourly	requires a visual check of all inmates every hour between 11pm and 6am	
10.19M	Annually	refresher training for the use of restraint chairs	
11.15M	Periodic	training on the recognition of the symptoms and characteristics of an individual on the autism disorder spectrum and appropriate responses to an individual exhibiting such symptoms and characteristics	
12.01M	Not more than 8 hours	requires inmates are not held longer than eight hours in holding cells, except when an inmate's behavior or intoxication prevents him/her from placement into general population	
12.02M	2 x daily	observation and communication with inmates during administrative and disciplinary confinement, including their attitude and general condition, by the jail administrator or designee at least twice per day	
13.05M	Annually	review of written plan for handling hostage/barricaded situations	
13.08M	Quarterly	fire and evacuation drill	
13.08M	Annually	review/revision of evacuation plan by key staff and local fire authority

14.03M	within 36 hours	inmates entering facility are provided copies of rules and regulations	
14.12M	Annually	examination of conformance with agency controls, policies and procedures of the property function is conducted by a member not routinely or directly connected with control of property	
14.12M	1 each year	unannounced inspection of property storage areas for organization and orderliness is conducted as directed by the agency's CEO	
14.12M	Annually	full or partial inventory, as defined by the agency, of inmate property is conducted by the property custodian or designee and a designee of the CEO	
15.03M	30 minute checks	requires correctional officers conduct documented observations, at intervals not to exceed 30 minutes, of inmates whose behavior presents a serious threat to the safety and security of the facility or staff	
15.04M	15 minute checks	requires inmates identified as being suicidal or a danger to themselves are not housed separately, or in single cells, unless they are under direct continuous observation with documented 15 minute physical checks. The facility health authority must certify in writing the inmate is medically cleared prior to the inmate being removed from observation.	
15.14M	Hourly	physical observations of pregnant inmate	
15.14M	Within 12 hours	reasons for restrictive housing provided to pregnant inmate	
15.14M	Daily	daily medical review by a qualified healthcare professional	
16.04M	Annually	prohibits commissary prices from exceeding the fair market value for comparable items sold in the community, with a documented annual comparison.	
16.11	Weekly	inmates in general population are allowed at least two hours of visitation per week	
16.13	Weekly	provides inmates a minimum of three hours per week of exercise in a recreation area, weather permitting. Uncontrollable or violent inmates and escape risks are not subject to this provision, but such exceptions must be documented and reviewed at least weekly for status change.	
18.02M	Weekly	specifies inmates are provided clean linens	
18.02M	Twice per week	inmates are provided clean clothing at least twice per week	
19.01M	Weekly	documented sanitation inspections with provisions for recording deficiencies and corrective actions	
19.02	Daily	requires floors swept and mopped, garbage receptacles emptied and cleaned daily	
20.02	2 x weekly	inmates in general population are required to bath no less than twice weekly	
21.01M	1 each year	food service operations conform to applicable standards of Florida Administrative Code 64E-11	
21.03M	Daily	requires food service employees and inmate workers are monitored at the beginning of each shift for health and cleanliness	
21.09	Weekly	requires the jail administrator or designee make documented weekly food service area inspections, to include deficiencies and corrective actions. Reports are to be kept a minimum of three years.	
23.02M	10 minutes checks	documented checks on juveniles placed in temporary custody	_

24.09M	Monthly	first aid supplies are readily available within the facility at all times and; inspections of all first aid supplies are conducted at least monthly, and expired or depleted items are replenished	
24.20	Within 48 hours	requires inmates confined for medical reasons are examined by medical staff within 48 hours of such confinement	
25.09M	Daily	temperatures of refrigerators used for storage of medications are logged daily	
25.09M	Monthly	cleanings and inspections are documented on a checklist or other form developed by the facility	
26.03	Annually	all cells are adequately ventilated and illuminated in conformance with FMJS requirements	
28.03M	Once per shift	if inmates are allowed outside of the facility to work, a written directive requires supervision with safety and accountability checks at least once per shift	
31.07M	Monthly	documented monthly inspection of First Aid Kit	
31.10M	15 minute checks	suicidal adult checks documentation of visual observations
